## Webster Lake Dam – Request for Charitable Contribution for Restoration and Maintenance Project

(Page updated February 2025)

Your charitable contribution is needed to help (a) fund immediate repairs to the Webster Lake Dam, (b) pay associated current legal and engineering expenses necessary to make those repairs and (c) establish a tax-funded conservancy district to be responsible for future repairs and long-term maintenance of the dam. This funding request is directed to all lake area residents and businesses regardless of WLCA membership.

Webster Lake Conservation Association, Inc. (WLCA), is a member funded not-for-profit corporation which functions as a Webster/Backwater Lakes voluntary property owners' association. WLCA owns only the gated weirs that are a part of the Webster Lake Dam and is taking the lead in establishing a tax-funded conservancy district for the purpose of making necessary repairs and providing long-term maintenance of all structures comprising the entirety of the dam. At the same time, WLCA is attempting to minimize potential taxpayer expenses associated with such a conservancy district by securing a firm commitment from the Indiana Department of Natural Resources (IDNR) and the State of Indiana to reconstruct or repair portions of the dam for which IDNR is contractually responsible. WLCA is also soliciting funds from town, township and county governmental units towards this project.

Over the past six years, WLCA has spent more than \$50,000 in litigation expenses to enforce a reconstruction and repair contract between WLCA and IDNR. Currently, IDNR has offered to repair a void and deteriorated concrete that exists under the apron of the downstream spillway which was omitted from the 2012 reconstruction of the primary gated weir. That concession is very much appreciated; however, there are more items for which the IDNR may be responsible. A February 2025, court ordered mediation meeting did not serve to bring the parties any closer together. It appears that a trial will be necessary. A trial date to determine the extent of the IDNR's accrued liability under the contract has not yet been set.

Under pressure from the IDNR, WLCA has had to engage both engineering and legal advocates for future representation regarding this project at an initial cost of \$78,000. Undetermined expenses will increase these estimated fees. This figure does not include the cost of any immediate repairs to the dam that will be necessary prior to the establishment of a conservancy district and legal fees needed to finish the current court case. The goal of this voluntary charitable contribution campaign is to raise at least \$200,000. There are relatively few residences and businesses related to these lakes so your most generous contribution will be greatly appreciated.

The Watershed Foundation (TWF) has established a restricted fund for the receipt of your tax-deductible donation to the Webster Lake Dam Project. TWF is a not-for-profit entity with 501(c)(3) tax status. TWF will confirm your tax-deductible donation in writing. TWF will hold your donations and apply them to expenses for this project.
